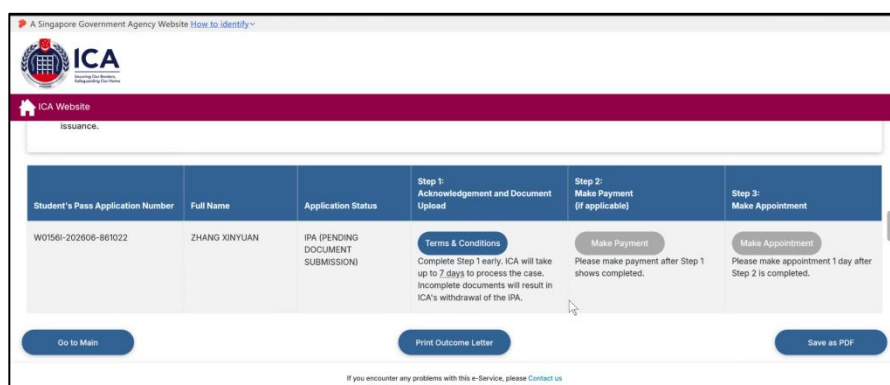
1. ICA 体检预约前提条件:

1.1 学生已经拿到 IPA

1.2 新加坡移民局 ICA 要求必须提交体检报告

- 学生已经拿到 IPA: 学生可前往自己的 MY MAIL 搜索 ICA, 通过邮件里面的 ICA 链接登录进去查看自己的签证申请状态 (View Application Status), 如果显示 “IPA (PENDING DOCUMENT SUBMISSION)” 则表示 “学生的 IPA 已经出具, 等待上传其他材料” (见下图 1)。 学生需点击 “Print Outcome Letter” 来保存和下载自己的 IPA。
- 学生拿到 IPA 之后, 可点击 “Step1: Acknowledgement and Document Upload” 按钮 (见下图 1), 前去查看移民局 ICA 需要学生提交什么材料, 大部分同学都会被要求提交体检报告 “Medical Examination Report”, 部分学生可能会被要求提交更多的材料, 具体需要提交什么材料要看新加坡移民局 ICA 的要求。请注意 ICA 的要求是 “Only upload duly completed documents. Incomplete documents will result in withdrawal of the IPA.”, 也就是 “仅上传正确填写的文件, 文件不完整 (包含没签字就上传等情况) 或不正确 (包含上传错材料等情况) 将导致 IPA 被取消。” 的意思, 所以同学们请务必提前规划好自己的时间并仔细检查自己的各项材料。

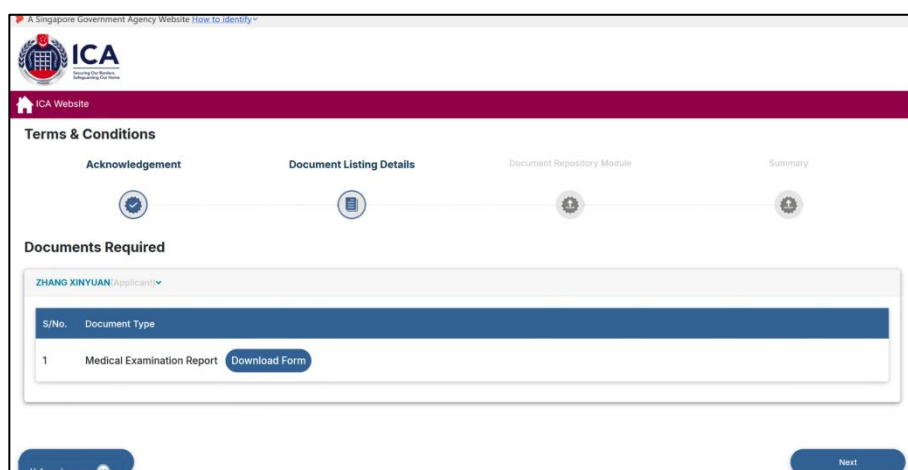

2. 预约 ICA 体检的流程、时间及注意事项等

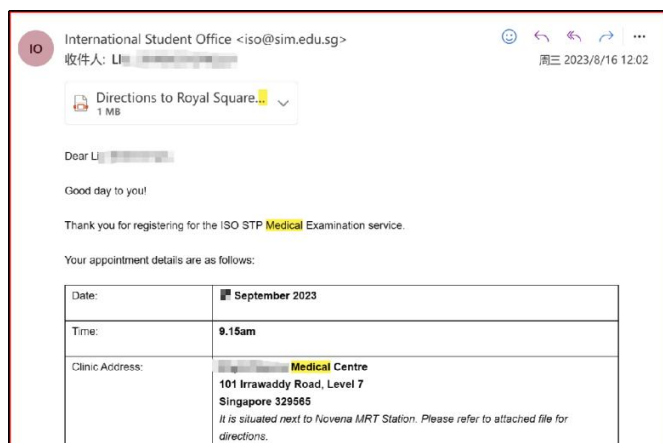

- 具体如何填写请参考文件《预约 ICA 体检-填写样例》，填写完毕后点击“提交”按钮即可。
- 学生需要每日去查看自己的 My Mail 邮箱，如果预约成功，学生将收到来自学校国际处 ISO (iso@sim.edu.sg) 发送的邮件（如下图 5 所示），邮件里面会说明学生体检的日期、时间、医院名称、

医院联系电话以及地址等信息，同时邮件里面还会有附件告知学生如何前往体检的医院。同学们可能会被分配到不同的医院去做体检，请同学们在预约好体检后去查看自己的 My Mail 邮箱，提前做好体检安排。如果一直没有收到这封邮件的话，可以主动用自己的 My Mail 写邮件给学校国际处 ISO (iso@sim.edu.sg) 问明情况。

- 请在前往医院体检之前携带好邮件里面要求的文件，一般建议至少携带以下文件：
 - A. 护照原件
 - B. IPA 打印件
 - C. Certification Letter 打印件 (学校会将此文件发送至学生的 My Mail 邮箱)
 - D. 过往病历、X 光片和现有药物 (如有)
 - E. 从 ICA 下载的 “Medical Examination Report” 空表，具体如何填写请参考文件《Medical Examination Report - 填写样例》，不会填写的话，也可以咨询医院负责体检的工作人员。

- 在医院参与体检之前的注意事项：
 - A. 请在预约时间前至少 15 分钟到达医院/诊所；
 - B. 此体检不需要付款，这项服务由学校为新的国际学生提供；
 - C. 学生在做体检前请明确和医院工作人员说明此次体检是为了向 ICA 提交体检报告；
 - D. 学生在体检后一般是通过电子邮件收取体检报告，具体需要等多久或者如何领取体检报告取决于不同医院的工作进度、要求及状态，学生可在体检现场咨询；有时候运气好的话，甚至可以当天拿到所有体检报告。
 - E. 如果您是糖尿病患者，请不要在预约当天的早晨服药或服用胰岛素。但可以继续服用常规高血压和/或心脏药物。

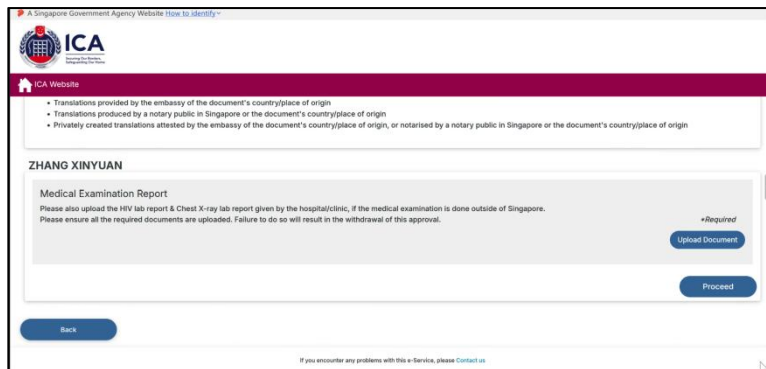
- 具体的体检项目需要根据体检中心的要求进行，包含胸腔 X 光检查、艾滋检查等；
- 建议学生确定好自己入境新加坡的日期后尽快预约体检 (建议在 9 月 7 日前完成体检工作)，学校体检预约每天有固定的量，如果不及时预约，可能会出现时间段已经被其他人预约了或者已经预约满的情况。

3. 上传体检报告 (Medical Report) 至 ICA 官网，上传时需要注意：

- 体检报告一般情况包含三份材料 (参考下面三份文件 3.1、3.2 和 3.3)，一份是已经填写好并且由医院签字盖章的体检报告表 (Medical Examination Report)，一份是胸腔 X 光检查报告 (Chest X-ray (PA))，还有一份是艾滋检查报告 (HIV Ag/Ab)，具体的体检报告还是需要以体检中心实际给出的为准。
- 学生在上传体检报告至 ICA 的时候，请务必仔细阅读 ICA 要求上传的是什么材料。如下图 6，ICA 要求

学生上传“**Medical Examination Report**”，那么学生就应该将**已经填写好并由医院签字盖章**的体检报告表（**Medical Examination Report**）、**HIV Lab Report**（艾滋检查报告）和**X-Ray Report**（胸腔X光检查报告）**三份材料整合成一个完整的PDF文件**（不超过2MB）上传至ICA。文件上传错误或者缺失等都将可能出现签证被取消的情况，**之前有学生只上传了其中一个材料，结果导致无法通过移民局ICA的审核，从而无法顺利预约录指纹并换取STP（学生签证）等情况。**建议学生上传前务必检查清楚是否上传的是正确的文件，并将文件提前命名清楚，例如：ZHANG SANSAN MEDICAL EXAMINATION REPORT。
