

新加坡入境卡填写说明

学生入境新加坡之前必须填写入境卡，如果不填写入境卡，将不被允许入境。学生可以采取以下几种方式填写入境卡：

第一种：登录 ICA 官网链接 <https://eservices.ica.gov.sg/sgarrivalcard/>，通过官网链接前去填写入境卡，**学生只能在入境前 3 天填写**。具体的填写步骤如下（以下仅提供英文版指导，学生也可以自行使用中文版本进行填写 <见下图 1 右上角，选择“简体中文”即可>）：

第一步：请点击“Submit SGAC”（见下图 1），进入到下一个页面并点击“In-Principle Approval Holder”（见下图 2）。

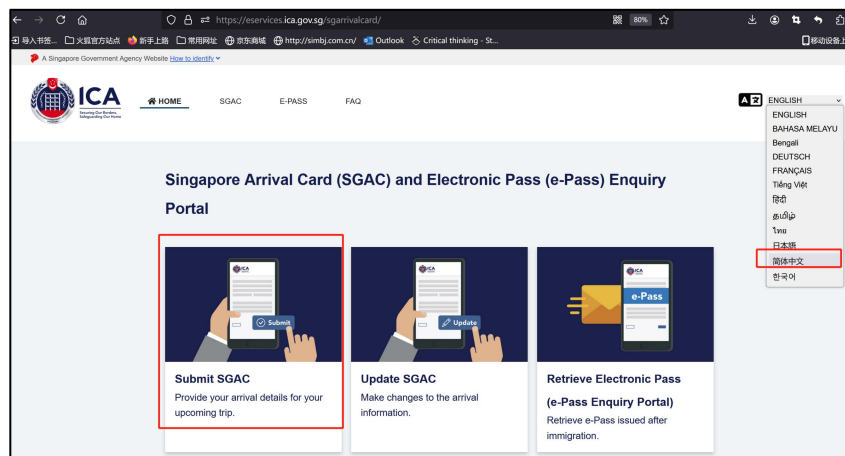
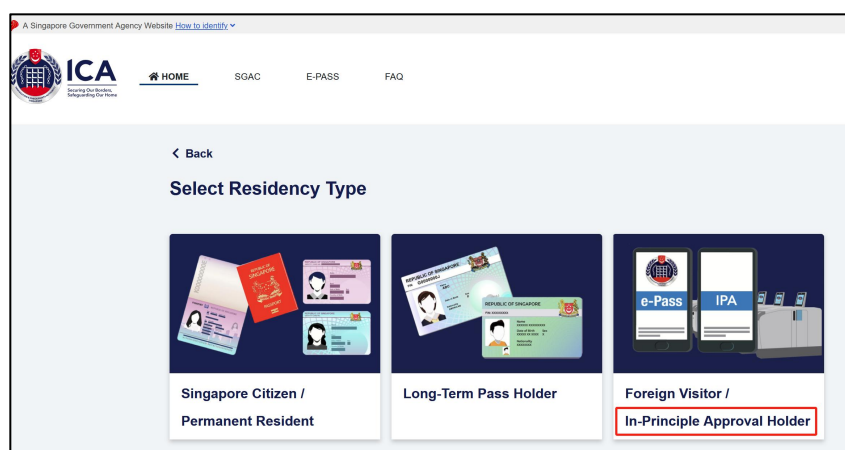

第二步：请根据 ICA 官方的指示填写入境卡信息（见下图 3），**Traveller Information**（出行者个人信息）（见下图 4），**Trip Information**（入境信息）（见下图 5），**Review**（检查），**Confirmation**（确认）。一旦确认，学生就不可再返回去修改前面的信息了。具体填写样例，请参考《**Traveller Information 填写指南**》和《**Trip Information 填写指南**》。填写 **Traveller Information** 的时候，如果学生在抵达新加坡之前的 6 天内去过所列的非洲或拉丁美洲国家（见下图 4），且需在入境卡如实补充这部分的行程信息。

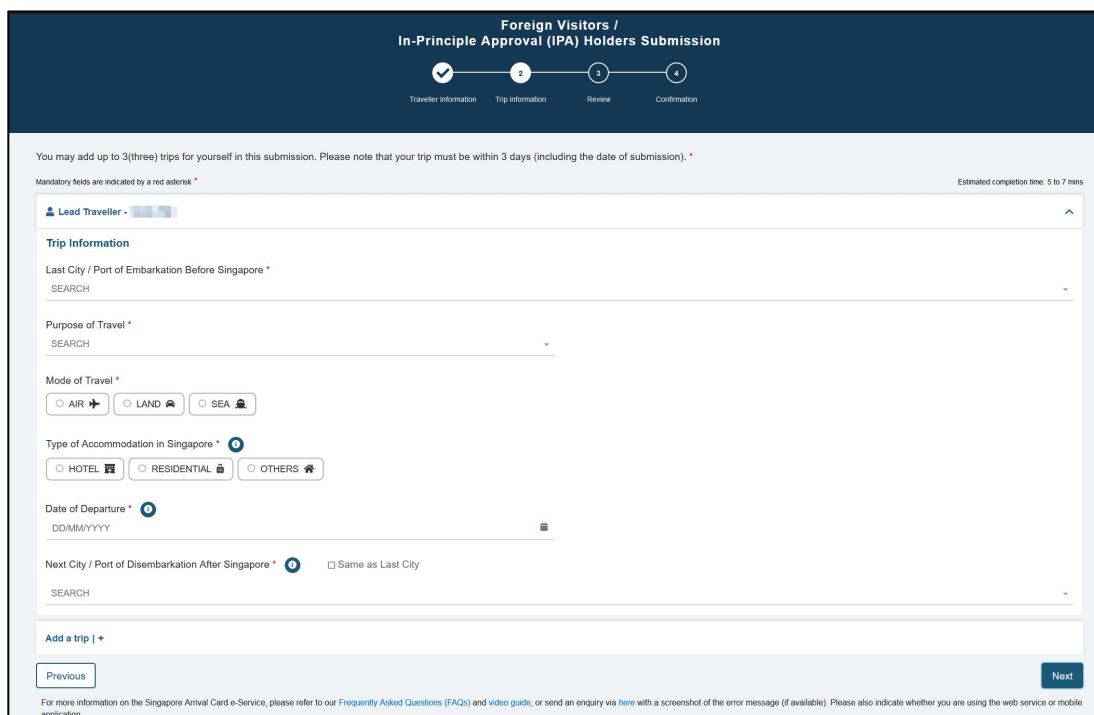

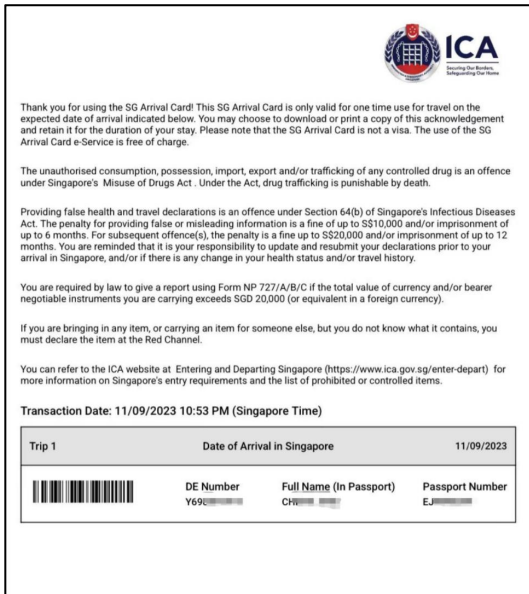

学生填写完 **Traveller Information**（出行者个人信息）和 **Trip Information**（入境信息）后，页面将会跳转至 **Review**（检查）页面，学生可仔细检查一下里面的信息是否存在问题，如果有问题可以返回去 **Traveller Information**（出行者个人信息）和 **Trip Information**（入境信息）修改，如果信息确认没有问题就可以 **Confirmation**（确认）了。学生确认后将收到入境卡填写成功的文件（见下图 6），请在入境前自行下载保存并打印，在入境过海关时，如果海关官员要求出示，请向海关官员展示如下图 6 的文件。

Providing false health and travel declarations is an offence under Section 64(b) of Singapore's Infectious Diseases Act. The penalty for providing false or misleading information is a fine of up to S\$10,000 and/or imprisonment of up to 6 months. For subsequent offence(s), the penalty is a fine up to S\$20,000 and/or imprisonment of up to 12 months. You are reminded that it is your responsibility to update and resubmit your declarations prior to your arrival in Singapore, and/or if there is any change in your health status and/or travel history.

You are required by law to give a report using Form NP 727/A/B/C if the total value of currency and/or bearer negotiable instruments you are carrying exceeds SGD 20,000 (or equivalent in a foreign currency).

If you are bringing in any item, or carrying an item for someone else, but you do not know what it contains, you must declare the item at the Red Channel.

第二种: 如果学生在出国前忘记去 ICA 官网填写入境卡，则可以在下飞机后入境新加坡前填写，如下图 7 所示，学生如果不填写入境卡则无法办理入境手续顺利入境。学生可以选择扫描二维码或者前往填写入境卡的机器填写入境卡（如下图 8 所示）。学生在填写的过程中不清楚如何填写的时候，可以参考上述填写入境卡的指导说明，也可以咨询机场的工作人员，机场工作人员会指导填写，但是填写完毕后，请记得**截图入境卡填写成功的信息或者拍下在机器上填写入境卡填写成功的照片**，以便过海关在海关官员需要查看的时候，学生可以向海关官员出示入境卡填写成功的证明。

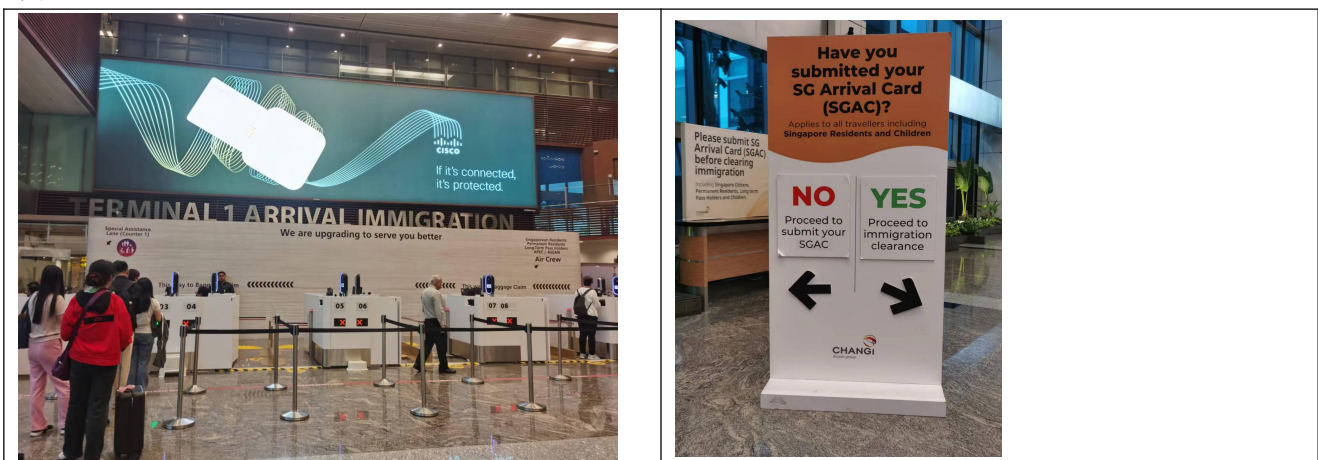
